What Happened Last Week?

PRESIDENTIAL RACE

- A decisive **victory** for Donald J. Trump

SENATE RACES

- Republicans **flipped** the chamber 53 R– 47 D (inc. 2 Is)*
- Four seats were flipped by Republicans*
- 1 Senate vacancy (TBD)

HOUSE RACES

- Republicans **held** control of the chamber, currently at 218 R – 209 D (Seven races still undecided)
- Seven seats flipped to Democrats; Seven seats flipped to Republicans
- Three vacancies left (red districts)



What Do We Know Now?

- ~ 23 Cabinet Nominees Announced
- Seven House Races Undecided
- One Senate Race Sent to Recount



What's on the Chopping Block?

- Increased Oversight: Congressional Review Act
 - Overturned/Rescinded Biden Actions
- Funding Pots:
 - Federal Work Study
 - Pell Surplus
 - Cuts & Level Funding
- Student Loan Forgiveness:
 - IDR/SAVE Plan
 - PSLF
- Executive Actions:
 - Title IX regulations (Trans students in athletics)
 - Travel Ban, Immigration/Visas

Trump 2.0 Higher Ed Agenda

- Dismantling the Department of Education
- Opposing “woke agendas” and “divisive” DEI proposals
- Tax university endowments
- Increase CTE and workforce skill development

- While full elimination of the Department is unlikely, offices, staff and functions can be moved by the administration.
- Trump and Republicans have expressed support for Income Driven Repayment plans but reject the SAVE plan established by President Biden.
- While there is some bipartisan support for risk sharing proposals, it is unlikely to pass outside a full HEA reauthorization.
- Likely scenarios are reversion of Title IX protections to the 'DeVos Rules' and a rollback of protections for transgender student athletes.

- Previous GOP proposals cutting OCR, FSA, and Department staff serve as a preview of potential budgets under a Republican controlled Congress.
- Trump and Republicans have expressed a desire to cut Title IV access for schools that promote "woke" DEI curriculum and policies.
- Republicans view teacher preparation as the purview of states and will likely seek federal disinvestment.
- While direct cuts to Pell grants are unlikely, full funding of the program is uncertain at best and may have the same effect.
- A Biden initiative, look for a Trump budget to cut these recent budgetary additions.
- Republicans have traditionally been supportive of the TRIO program; it is not unreasonable to believe they could be spared from major cuts.

Probable Early Actions



Deportations & Visa Denials

- Expanded deportations and increased visa scrutiny were key campaign talking points, chilling student and faculty recruitment.

Expanded Accreditation

- Trump has promised to upend 'Marxist' accreditors while deregulating the federal accreditor approval process.




Privatize Student Loans

- End Biden's student loan forgiveness plans and revert to a pre-Obama private student loan system.



Research Funding Cuts

- Use of budget reconciliation process to make significant cuts to domestic/social spending.
- Grants and programs increased during the Biden administration are prime targets.




119th Congress: Senate Makeup

■ Rep. ■ Dem. ■ Ind.




- Republicans flip 4 seats


FY25 Appropriations Update

- **Recap of FY25 Appropriations**
 - Short-term Continuing Resolution (CR) approved through December 20.
 - Potential for 'Minibuses or Ladder Votes'
- **House vs. Senate Proposals**
 - Cuts vs. Level Funding
- **Budget Reconciliation**
 - Expedited consideration of specific tax, spending, and debt-limit legislation
